General: (GSIG) Corrections Committee is comprised of Group and District Representatives meeting within the Greater Seattle Area as well as Elected Trusted Servants and Facility Coordinators. The Corrections Committee is held at 6:30 PM on the second Monday of every month. This is a hybrid meeting at Seattle Intergroup, 5507 6th Ave S. and Zoom ID: 872 2771 9137 Passcode: 833575.

Corrections Bridge: Contact a released incarcerated person within the first 24 hours and get them to a meeting within the first 48 hours of their release. Help them get to 2-3 meetings so they can meet AA members and get phone numbers. Corrections Committee: Make yourself available to serve as a group, district, or committee level Corrections trusted servant. Sobriety requirements varies with position. No background check required. <https://www.seattleaa.org/service/corrections/>

Corrections Correspondence: Carry AA's message through letters to persons in custody who have a desire to stay sober. You are assigned a person outside your state or province and may use a PO Box, Intergroup's address or your own. There is no sobriety nor background check requirement for this service. <https://www.aa.org/corrections-correspondence-special-kind-aa-service>

Corrections 12-Step: (By Phone): Answer calls for released persons in custody within the first 48 hours of their release. Direct them to a meeting or arrange to meet them at one. There is no sobriety requirement of clearance for this service. **(In Person)** You and another alcoholic take an informal meeting to a recently released incarcerated person via traditional 12-step call. One year sobriety and finished working the steps is suggested. No clearance required for this service. **Sign-up and add note: "Corrections 12th Step Calls"**

 - AA Meetings: Women and Men not seeking new volunteers.
